Complaint

I am filing statutes on the Central Intelligence Agency, for possible conspiracy against me, Chris Roller.

- Conspiracies to Interfere With Civil Rights (42 U.S.C. § 1985)
- Conspiracy Against Rights of Citizens (18 U.S.C. § 241)

The CIA have been watching me for the over 20 years now. No one believes I'm being watched by the CIA because the CIA don't tell the truth. This results in the perception that I'm crazy. I've been seeing psychiatrists for over 7 years now because the CIA don't come forward. I have sent over 2000 messages on the CIA web site with no formal response.

42 U.S.C. § 1985 (3) - "if one or more persons engaged therein do, or cause to be done, any act in furtherance of the object of such conspiracy, whereby another is injured in his person or property, or deprived of having and exercising any right or privilege of a citizen of the United States, the party so injured or deprived may have an action for the recovery of damages occasioned by such injury or deprivation, against any one or more of the conspirators."

By not coming forward about the project to watch me, this has resulted in a

miserable life, seeing psychiatrists because I'm crazy; divorced without family, disabled, drugged up, poisoned, jobless, friendless. All this because the CIA have conspired against me, watching me instead of coming forward to inform everyone that I am indeed god and accurate about www.MyTrumanShow.com.

18 U.S.C. § 241 "If two or more persons conspire to injure, oppress, threaten, or intimidate any person in any State, Territory, Commonwealth, Possession, or District in the free exercise or enjoyment of any right or privilege secured to him by the Constitution or laws of the United States, or because of his having so exercised the same", "They shall be fined under this title or imprisoned not more than ten years, or both; and if death results from the acts committed in violation of this section or if such acts include kidnapping or an attempt to kidnap, aggravated sexual abuse or an attempt to commit aggravated sexual abuse, or an attempt to kill, they shall be fined under this title or imprisoned for any term of years or for life, or both, or may be sentenced to death."

I have been oppressed for over 20 years because the CIA don't come forward about watching me as expressed in www.mytrumanshow.com, leading to my miserable life.

I may be wrong, so I'd like to conduct a test...

People would make fun of me, "Chris, it doesn't make sense that a god or God would have to sue people to prove himself or have money". I think I've figured out the reason. I am under the impression that people can't lie to me under oath. Now that would be impressive if true, since everybody is full of it or corrupt. Imagine, no more Clintonitis (Clinton lied under oath). Wow! After all, David

Copperfield fessed up to godly powers. I seriously doubt he wanted to do that. "I swear to tell the truth, the whole truth, and nothing but the truth, so help me God." 2. The CIA have never had a project for which to watch Chris Roller.

4. The CIA is not aware of the use of godly powers inspiring and promoting the Iraq War.
5. The CIA is not aware of the use of godly forces inspiring and promoting 9/11.
6. The CIA is not aware of any immoral use of godly powers on planet Earth.
7. The CIA has never fell victim to demonic godly forces.
8. The CIA is not aware of any financial gain in the use of godly powers on planet Earth.
9. The CIA is not aware of Chris Roller exhibiting godly powers.
10. The CIA is not aware of any crimes committed against Chris Roller.
11. No member of the CIA has ever tried to kill Chris Roller.
12. The CIA is not aware of any poisonings done to Chris Roller.
13. The CIA is not aware of any psychiatric conspiracies against Chris Roller.

36. The CIA is not aware of the "fess up" phenomenon.

This is to test my "fess up" phenomenon theory. I'm betting the farm on this experiment. If the reply to the complaint has, in verbatim (simple copy and paste), all the above statements, I will dismiss this case immediately. If statements are missing (meaning admission of the opposite) pertaining to godly powers, then we also have a case of patent infringement in accordance with U.S.C 35 § 27. If so, I will have to take that up in United States Court of Federal Claims, or transfer this case there.

I don't want to hear any lame excuses by the defense that a lack of statement means nothing. It means you cannot lie to me with a false statement. It's important, to test my "fess up" phenomenon.

Again, this is very important. If any of these statements above are missing in the reply, then it will mean an admission of the opposite ("does not" means "does", "has no" means "has", etc.). It's very simple - copy and paste the statements into the reply, if you can, and I will dismiss this case.

Depending on the statements (or lack of) in the reply, then we have a case, and I will need to ask the CIA more questions.
