It's official. I am God! Don't call the Looney bin. Simply file perjury charges on me if you think I'm wrong.

I sued David Copperfield, simply making accusations about godly powers. I found out, under oath, I was right. He's got my godly powers. So then I sued Joel Osteen (preacher from Houston) with accusations I'm God, similar to below, to find out what he's thinking under oath. I'm suing for tort for fraud for tithing (deceit - intentional misrepresentation) compensation, inclusive ONLY for the month of September 2010. I'm suing for tithing fraud for the month of September 2010 only. I am suing for 25% of September's tithing, tithing which should be directed to me, Chris Roller, since I am the Messiah, Jesus, God's representative and the Savior of planet Earth.

Religious leaders have built up a network of deceit centered around the religious industry. Joel Osteen knows I'm God, but falsely preaches crap from the Bible as the word of God, even though he knows that www.mytrumanshow.com is the word of God. He knows Chris Roller's life is the journey of God.

So this is very simple for the church, to avoid this lawsuit. All you have to do is tell me under oath that Chris Roller is not God/Messiah/Jesus. I allege I am God/Messiah, the only God/Messiah, the one and only. But if people wish to believe that something else is God/Messiah, like Jesus of Nazareth, or your neighbor, or David Koresh, simply state it. That's freedom of religion and I have no problem with that. Believe what you want. Messiah=symbolic name for the entity representing God. Chris Roller also states he is the Messiah, the savior, direct representative of God for the good of humanity.

I've been in the court room before, and despite begging for a statement a dozen times, and I have yet to be told I'm not God yet. By the way, I believe the courtroom is supernatural, making people tell the truth under oath, especially if it's supernatural/godly. It's my magic trick, called www.TruthUnderOath.com, the only miracle on the planet, and one of the greatest miracles the planet will EVER see. This is why I am God, enforcer of truth/justice. Here's my statements of allegations that are true unless the defense denies/counters the statement.

3. Leaders of [Church] are commencing the hugest con on the planet, deceiving their tithing-congregation to give to the church, instead of giving to the actual Messiah, Chris Roller.

Lack of these statements indicates that the church cannot tell the opposite, because it would be a lie, and under the oath now, no one can lie, and that's why the church cannot deny the claims. So no statement indicates that Chris Roller is Jesus, and that the church should not be receiving tithing for their monetary gain. Chris Roller should be receiving tithing so that I, Chris Roller, who is Jesus, can better affect the lives of people giving in the name of Jesus.

This case is very simple. No lawyers needed. No legal ramblings and runaround please. Just make the statements. It's nothing personal against the church. I'm just trying to get some answers to what you "really" believe, all while getting some money due to God. If you're mad at me, don't be. If Joel Osteen or his lawyer had told me, "Joel Osteen knows that Chris Roller is not God", this case would never have been filed. And the only way to survey churches of the truth is via the courtroom (under oath), thus a law suit.

Amount is estimated. Bring your September 2010 accounting books to the courtroom to view how much tithing was reported. Federal fraud is USC 18 § 1038. Statute of limitations is 6 years in Mn. per MN § 541.05 from discovery of the fraud.

Fraud - the crime of obtaining money or some other benefit by deliberate deception.

Warning to the judge: If I feel you are not judging honorably in this case, or discriminating against me because I am God, I am not afraid to take you to court for breach of judiciary duty. I am God, and expect to be treated with respect and fair judgment.

CONCLUSION

Churches are not clubs. People donate tithing in the name of God, hoping to get back more than they gave, so that it makes their life better (get back more than they receive).
