Religious Freedom/Rights

1. On October 28, 2004, I went to Quello Clinic in Burnsville, MN for a referral to get my head MRI-scanned, because in 1999, I suffered two concussions from snowboarding and in the years since, a psychiatrist/psychologist or two recommended that I eventually get a scan to see if everything is OK up there. I explained to Dan Reeves my story of MyTrumanShow.com and how it evolved at about the time of the concussions. In the discussion, I told Dan Reeves my journey in '99 as I'm becoming God. In describing the events of 1999, Dan Reeves said that I was delusional - that I was going to kill somebody very soon. In very deceptive fashion, he called the police, who then escorted me to Fairview University Hospital, where I was put on a 3 day hold because I was a threat to society and/or myself.
2. Dan Reeves and Fairview knew that I was running for President of the United States at some point in a future, and that I have a political website stating so - FreakAndGeek.com. Dan Reeves and Quello Clinic's (and Fairview) actions created character defamation. This is assassination of character, and in order to stop these organizations from assassinating smart people who defy their religious belief system (in God), requires a huge penalty in society. They're trying to harm the credibility of a person trying to run for President of the United States. When Dan stated that I'm going to kill somebody very soon, then in very sneaky fashion, admit me to a mental institution, he is telling society them I am unsafe and mentally unstable to run a country - that I'm not credible nor competent. Like a police shooting, an officer (analogy to Dan Reeves) has the right to pull the trigger. It's then left to an investigation to determine if the actions were correct, and award appropriate damages.
3. My statement that I am God, though different than most beliefs', may be delusional, but I'm not harming anybody by stating my beliefs. There are millions of people in this country who believe that God exists and that there is a heaven after death, yet there is absolutely no proof of these claims. This makes all these people delusional! Do we put them into a cage because they're delusional? Of course not! They're not hurting anybody because they have what's called "Faith". There are thousands of denominations - almost all of them have a system of beliefs based on Faith - some more accepted than others. Faith is an accepted norm for delusional thoughts, and we all need to be tolerant of our unproven beliefs (delusions). My faith is no different. Like any other faith belief system, I'm not harming anybody by the things that I say. I'm not calling myself Ted Bundy nor Jeffrey Dahmer. I call myself God, where I attempt to heal people at WishMission.com and say that I'm going to create heaven on Earth eventually, and I don't see how that could imply that I was evil or dangerous to myself nor somebody else. Dan Reeves based his decision on religious norms (perhaps his faith), and since it differs from mine, made the decision to undermine my credibility, call me delusional with bi-polar disorder (mental illness), and attempted to assassinate me socially, in life, my future, and for the Presidency of the United States.
4. The defense may try to prove me non-credible because I can't prove the existence of features in my

show (my faith), but the defense can't prove the delusions of the majority populous who think there's a God and heaven after death (their faith). Faith does not need to be proven.

5. The stigma of mental illness carries some huge consequences. Some doubt my ability and credibility on the job and in person, others are scared of me - even think I might kill them or others (like Dan Reeves). This is not an image people envision for the Presidency. I'm now disabled thanks to my story (my faith) and professionals calling me delusional and mentally ill (bi-polar). Four powerful people from CBS were fired when 60 Minutes falsely portrayed George Bush negatively. What should the price be for calling me mentally ill and dangerous. And what is the penalty for the actions perpetrated due to mental illness - by throwing me into a cage for speaking my faith - for calling me dangerous to society without any proof to back up the claim.

I'm asking Quello Clinic and Fairview to each pay \$1,000,000,000 in damages suffered from character defamation, slander, my future credibility and reputation in life and for the Presidency of the United States.
