**RESPONSE TO DEFENDANT'S  
ANSWER AND AFFIRMATIVE  
DEFENSES**

3. It told Kristi (Lastname?). Word was getting around because Rich Adcock eventually told me to shut up or I may have to leave (fired) - shortly before 1Nov1999 when I purchased my home.

15. Bob Moore did visit me in person at Sioux Valley Hospital Behavioral Health Services after communicating by phone why I wasn't at work.

17. Announcement doesn't mean over the intercom. Noah Allard, Bob Moore, Rich Adcock, and Troy Allard knew what happened, and people do gossip.

Here is a summary what happened prior to Aug 24 2000 institutionalization (caging).

I caught Heith Hendrickson (System Administrator) twice with a copy of an email I sent (not to him) in his inbox. The 2nd time, he nearly had a heart attack when he got caught. I started sending emails to tick 'em off (they were sniffing/peeking my emails I sent to others). It was all bull crap - a little gag. I'm a prankster. I kept thinking they would come forward and ask me what the heck is going on. Instead, Russ laces a soda of mine. I'm messed up pretty good, but didn't drink the

whole thing thanks to my 6th sense - got lucky. I knew Rich Adcock wasn't a part of this, so I gave him a call on his cell...he said he would put hidden cameras in. Day or two later, the same group was trying to finish the job....had to be careful about what I drank....things were going on. Called Rich again...this time, he said "Chris, have you taken your drugs". He violated some laws saying that, and left me to fend for myself.

Within days, the alleged pizza poisoning occurred and I was caged. Rich Adcock knew what was going on throughout the incident. Rich Adcock knew I was mentally ill from day 3 of working there, Micro-medical, which was later bought by GE. He even contacted Allina (Sioux Valley partner) in New Ulm MN to see if he could assist me in my mental disorder. Workers there, like email System Administrator, Heith Hendrickson was peeking at (sniffing) my emails, and knew of my affairs via my email.

Also, manager Troy Wollman was well aware of my affairs before and after this caging (we were friends and talked about everything on MyTrumanShow), and was employed and present during my firing. Managers talk.

Also, Lutheran Social Services conducted a GE-paid assessment to determine my mental state (anger management). In the meetings, I told psychologist Rita Weber everything on MyTrumanShow.com and my bi-polar diagnosis. All this information was given to GE before the firing.

19. Bob Moore visited me at the mental hospital.

22. The discussion did occur. I told Bob the Zyprexa dosage made it very difficult getting up in the mornings, and like a tranquilizer, hindered my

productivity on the job. Despite this, my work was satisfactory since I continued getting raises.

23. Bob Moore knew I was taking drugs related to the caging that occurred in Aug 2000 at Sioux Valley where he visited me. Rich Adcock and Troy Wollman also knew I was taking drugs to remedy bi-polar disorder.

24. A very bold statement by the defense. There were no physical altercations. Notice the defense doesn't mention any names because there are none.

### **AFFIRMATIVE DEFENSES**

6. SD Statute 20-11A-2 - Contract made before adjudication of incapacity subject to rescission. Legally disabled from mental illness on 18 Feb 2002, before the signing of the contract on 24 Apr 2002. The contract is null and void - rescinded.

9. Defense is stating that if they knew I was mentally ill, then "To the extent Plaintiff had a disability, upon information and belief, Plaintiff posed a direct threat to the health and safety of himself and others in the workplace." This is a bold statement and why I'm suing. They knew I was mentally ill, and they thought I posed a direct threat to the health and safety of himself and others in the workplace. Somebody (Kevin Impevocen?) had a fear issue and was prejudiced, and administration didn't ask me my side of the story.

### **CONCLUSION**

This case needs to continue. Defense has trouble telling the truth. GE knew I was mentally ill Jesus guy, and they thought I "posed a direct threat to the health and

safety of himself and others in the workplace". They discriminated (violated SD § 20-13-1(16)) against me, not just for mentally ill, but religious discrimination because of my Jesus story MyTrumanShow.com, for fear that I was a false prophet (the devil).
