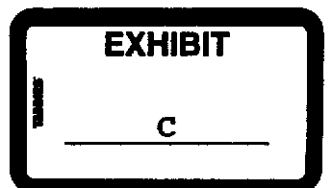

5 A No, I didn't.

6 Q Okay. Sorry about that. Who were the -- you mentioned

8 concerns for their family's safety because of me last
9 being last -- past Friday. Who are these two employees

10 A I'm sorry, can I see that again? Which argument?

11 Q Well, this isn't referencing -- there's an argument
12 that occurred before. I'm not referencing a certain
13 item on there. There was a certain argument that I had

16 A That's referring to that argument, yup.

17 Q Okay. Well, the argument occurred the previous Monday

21 was a whole week before that, you know. In other
22 words, the argument occurred an entire week before I
23 was dismissed, you know. That's what got me so

22 Q I mean I've got a little bit -- I've got to do a little
23 catch-up here, but I didn't get that much catch-up.

24 Bob, are you a little mad that I'm suing GE for
