Complaint

I am filing statutes on the George Bush administration, for conspiracy against me, Chris Roller, a godly entity, and type 9 conspiracy to plan 911.

- Conspiracies to Interfere With Civil Rights (42 U.S.C. § 1985)
- Conspiracy Against Rights of Citizens (18 U.S.C. § 241)

My purpose in this complaint is not to have George Bush and his administration necessarily arrested, but simply to make them accountable for their actions on 911 and the Iraq war, so that an impeachable offense (crime) can be used against them.

I have recently proven conspiracy against me, Chris Roller, a godly entity, perpetrated by the mob in a quest to turn me into type 9, or make me look like one (a false prophet).

Godly powers are being used on the planet according to my lawsuit with David Copperfield (case 05-446). The lawsuit also shows that there is a conspiracy against me by the mob, who have somehow acquired my powers, and they're using them in deceptive manners, like magicians concealing powers as "illusions". I also suspect technology is assisted by godly powers, like chip manufacturing, and given an explanation like "it's lasers cutting silicon wafers". All the magic being used on the planet has to have a fairly real explanation.

- *Type 9 - Cold-hearted* - a person who enjoys the pain and suffering and hardships of other people. These people say something for pro-chaos, but buffer it with a phrase that socially

acceptable and sounds innocent - a dualism. The best example is "Jesus died for our sins", can actually mean to the type 9, "Go ahead and sin because you'll be forgiven." And since sin is undefined, that leaves the door open for anything evil, like the actions the mob exhibit. Non-Type 9 would say, "Wow, I'm glad Chris Roller is on Social Security because people and companies have been wronging him." Type 9 instead say, "Chris Roller is mooching off the system and should go out and get a job, the bum!"

These people may not be evil/hateful in their actions, but in their thoughts and words, and who they say it to. Their sole is tainted with evil. Their heart has grown cold - their internal light has grown dim. These people hate everything my web site stands for, and will call me the evil one. I. e. "Don't trust him - he's a false prophet. Don't give him a chance to do good he claims, cause he's just fooling you". These people actually enjoy the current war, but they buffer it with a common pro-war/non-type-9 phrase, "We need to fight for freedom and democracy throughout the world." Another common neutral statement is "For our safety and fear of a very few terrorist groups, lets take the war against terrorism overseas before it reaches us." But type 9s will think, "Lets go out and kill people because war turns people into type 9s". Ironically, suffering and hardship turns people's internal light off, in turn, making them want other's to suffer - in sort-of a contagious spiritual virus, one that I'm not sure can be cured - "fell down (into hell) and can't get up". Once the heart grows cold, I'm not sure it can be warmed with much security of it staying warm. Drugs can also turn people cold. Religious brain-washing (Christian upbringing) somehow turns people against me. Some are born this way. If not, each person has a different suffer-resistance before they "go to hell in a hand-basket".

Type 9 loves to be rich and does not like to suffer, and when they see a veteran on the side of road homeless with sign, instead of giving them \$10, they say, "Wow, I'm glad I'm not him." Or when somebody dies, they say, "Wow, I'm glad that wasn't me." Or when they hear about a soldier that dies in Iraq, they say, "Wow, I'm glad we're rich so our kids don't have to enlist, and can stay out of that mess", or "I hope he took 10 Iraqi's with him", instead of something more caring/respectful like, "Wow, I feel for the parents of that soldier. I wonder if this war is worth it." They promote fear in the public, then use the fear as an excuse/catalyst to go to war and start killing. That when I say I'm the 2nd coming, they say "You are not, but the devil in disguise". Or psychiatrists saying, "you're crazy Chris", or "You're experiencing an episode, Chris" shortly after showing court papers that godly powers are on the planet. Or "Chris, you're manic because you speak fast" instead of "you speak fast because you're mind is so quick and smart".

The only time type 9 will give anything (like charity) is when it's of a public nature - so that's everybody knows that they're a good guy, even though, internally, they're thinking "this sucks". Type 9 would best be described as a good-guy con-man.

If you think promoting chaos throughout the world, is the way for peace throughout the world - "create chaos to create peace" philosophy vs. "contain/control chaos to create peace", you are probably type 9. Notice the distinction is quite fine-lined, as it is easy for some people to become cold, and convince you that they're not.

I live next door to a mob man who's dad is a billionaire. I've spoken with him many times. In our talks, he explains that the mob owns the country, and the Mafia runs the country. The Mafia are mob members turned political. In talking with him, I found out there is a trillionaire in the Minneapolis area - he calls his "cousin". From the David Copperfield case, the mob are receiving godly money and are somehow hiding it via tax loopholes. It's my understanding that there are hundreds of these trillionaires throughout this country. If that money were put into normal taxable use, it would pay off the deficit, but these trillionaires enjoy the good life while watching the country/people go bankrupt. This is type 9 behavior. I believe these trillionaires are Masons, a hidden group, in which all Presidents have joined, according to one Mason I met. www.freemason.com - this may be Mafia central.

From Fahrenheit 9/11, Michael Moore pointed me to some key evidence against George Bush on 9/11.

- On 9/11, when the First tower was hit, and during the 2nd hit, George Bush opted to go into a school and read a book for 10 minutes before doing something about it. This is documented in Fahrenheit 9/11.
- Then on the golf course, Bush makes it remarked "we need to stop these terrorists. Now watch this drive". This is one of the most callous remarks I have ever heard, to know that people and soldiers are dieing, yet "watch this drive." This is typical of type 9. He could give a crap!
- 9/11 - The Bin Laden's, guests of George Bush, were allowed to exit the country 3 days after 9/11 occurred. Fahrenheit 9/11 also documents the connections between George Bush and Osama Bin Laden.

This seems amazing that a complaint of this nature has not occurred before, given all the overwhelmingly damaging evidence that Fahrenheit 9/11 displays. I think the only piece of evidence missing was why and how (the conspiracy against me using godly powers). It would seem that God's plan was waiting for me to impeach George Bush and his administration.

On the morning of 9/11, I was getting hair transplants done for my receding hairline. At the exact moments the first tower was hit, the doctor just took out the skin on the back of my head that would result in my first scar. I got the second scar from the same plastic surgeon three months later, in a follow-up. I receive complements all the time from people asking if I had a lobotomy done. I call these wonderful looking scars my 9/11 scars. My first 9/11 scar seems like an unbelievable coincidence, or with recent evidence, a conspiracy to make me look like I was responsible for 9/11 and terrorism throughout the world.

One night, I met a clean-shaven man who admired Saddam Hussein's tactics in using terror to control people. He also had political interests. I inferred he was the Mafia. In our discussion he told me he hated paying taxes. Also, that 9/11 planes can be (were?) flown with magic. Also, that oil fields are a replenishable resource - that is not simply made from decayed plants and animals. The can only this can occur if magic is being used to replenish oil reserves. This is how I think there are so many trillionaires - the Middle East oil reserve is governed by the mob, sold to the US, and the money funneled into the

US mob tax free.

Now if the major oil supplies in the world are housed in the Middle East, that would make Iraq a very powerful money reserve. But you see, I believe, ironically, that the mob was getting a cut of the oil reserves in Iraq already, but Iraq and Saddam were made pawns in the game by George Bush and the Bin Ladens solely to create type 9 chaos in Iraq. With no WMDs and no pullout of troops, that seems evident.

The 2000 election was incredibly close, almost miraculously close. Almost as miraculous as godly powers are on the planet. In fact I believe that's godly powers were being used by the mob to help rig the election, not just to win, but to show how close the Mafia can make the election, and still win, as though they were taunting me and the whole country with what they can pull off. As a result, this would put George Bush into office. Then in almost identical fashion, the 2004 election was decided on one state, Ohio - not quite a cliffhanger as 2000, but quite rare. With Fahrenheit 911 portraying the deception by George Bush, who would vote for him. Amazingly, George Bush won! I do believe that magic was used to rig the election.

I will later bring forth points mentioned on <http://www.votetoimpeach.org/> which point to deceptively creating type 9 chaos throughout the world.

1. Seizing power to wage wars of aggression in defiance of the U.S. Constitution, the U.N. Charter and the rule of law; carrying out a massive assault on and occupation of Iraq, a country that was not threatening the United States, resulting in the death and maiming of tens of thousands of Iraqis, and hundreds of U.S. G.I.s.
2. Lying to the people of the U.S., to Congress, and to the U.N., providing false and deceptive rationales for war.
3. Authorizing, ordering and condoning direct attacks on civilians, civilian facilities and locations where civilian casualties were unavoidable.
4. Threatening the independence and sovereignty of Iraq by belligerently changing its government by force and assaulting Iraq in a war of aggression.

This complaint may be untimely in the wake of Hurricane Katrina, but I also have suspicions about the mob using godly powers to make that disaster more devastating, all occurring days before my crucial David Copperfield hearing on 2 Sep 2005. I am also suspicious of the London bombing.

I believe 911 and the War in Iraq was conspired by the George Bush administration under the guidance of the mafia, with godly powers at their disposal, in a quest to try to set me up as a false profit, like I am responsible for these events and everything bad in the world. I am suing the Georgy Bush administration, for \$1 trillion, for conspiracy against me, Chris Roller, in accordance with 42 U.S.C. § 1985 and 18 U.S.C. § 241.

AMENDMENT TO COMPLAINT

FACTUAL BACKGROUND AND ARGUMENTS

I found out that Conspiracies to Interfere With Civil Rights (42 U.S.C. § 1985) and Conspiracy Against Rights of Citizens (18 U.S.C. § 241) doesn't really infer me and now I have to amend the complaint for MN § 609.05 (6) as the claim for relief.

It seems there is some confusion about god and God's plan. Bush has conveyed he's a God believer (has faith). Evidently, Bush's version of God is different than mine, because his version must enjoy creating chaos for the planet. See Supplement - Type 9.

MN § 541.05 Various cases, six years.

(6) for relief on the ground of fraud, in which case the cause of action shall not be deemed to have accrued until the discovery by the aggrieved party of the facts constituting the fraud;



Fraud (Encarta)-the crime of obtaining money or some other benefit by deliberate deception

Fraud - something intended to deceive; deliberate trickery intended to gain an advantage

The deliberate deception has been in hiding godly powers while injuring me in a cover-up. This statutes gives me 6 years to file this suit from the discovery of the fraud - June 15, 2005.

MN § 541.31 Conflict of laws; limitation periods.

Subd. 2. Action arising out of state; resident plaintiff. If a cause of action arises outside of this state and the action is barred under the applicable statute of limitations of the place where it arose, the action may be maintained in this state if the plaintiff is a resident of this state who has owned the cause of action since it accrued and the cause of action is not barred under the applicable statute of limitations of this state.

This means I can apply MN statutes to any state.

MN § 541.34 Existing and future claims.

Sections 541.30 to 541.35 apply to claims arising from incidents occurring on or after August 1, 2004.

I can apply MN § 541.31 to the defendant because the discovery of the fraud (David Copperfield using godly powers) occurred after August 1, 2004, on June 15, 2005.

MN § 609.05 Liability for crimes of another.

Subdivision 1. Aiding, abetting; liability. A person is criminally liable for a crime committed by another if the person intentionally aids, advises, hires, counsels, or conspires with or otherwise procures the other to commit the crime.

Supplement includes discussion of George Bush and his type 9 deception on the world, me, God's plan, what is heaven, and how George Bush has managed to create a chaotic hell on Earth.

George Bush (GB) participated in aiding and abetting to concealing godly powers with the mob, and accessory and accomplice for fraud in conspiring and covering up the murder of nearly 3000 people on 9/11, and accessory to the mob/mafia trying to make me look like the god responsible for 9/11 - a false prophet. I'm not saying that GB necessarily knew about me, but the mafia/mob did, and GB did conspire 9/11 with the mafia, and the mafia conspired 9/11 to set me up. Vaughn Meyer in Sioux Falls, SD, was the plastic surgeon who worked on my hair plugs the morning of 9/11. Normally, this produces no scars. Instead, I have gashing/ hideous 9/11 scars. There was an alleged poisoning in Aug 2000 covered up by a Sioux Valley Hospital (case 05-1420) via the mafia. This would further stamp the seal that I was mentally ill, insane, and crazy in hopes that I'm a psychotic god who could cause 9/11. As a result of this incident, the drugs I was forced to take in massive dose are named Zyprexa and Depakote, drugs that prevent mania - prevents me from feeling good, and may have a spiritual side-effect of making my godliness not feel so well either. Global terrorism did not happen before taking these drugs to cure my bi-polar disorder. It seems these drugs make the world un-safer (allowing 9/11 to occur). This crazy-notion by the mental community (and

throughout the world. GB is mafia - GB is a terrorist. This is what Fahrenheit 9/11 exposed. It's what everybody joked about, yet GB walks free and somehow gets re-elected. Type 9s must run pretty deep in the government to prevent the investigation of GB after Fahrenheit 9/11.

From 60 Minutes, In Feb 2002, Joseph Wilson, CIA, reported that a purchase of Uranium from Africa was unlikely. Following this, Bush stated in a State of the Union address, the opposite. Joseph Wilson then called the Bush Administration liars. In retaliation, the white house leaked Joseph's wife, Valerie, blowing her cover and perhaps endangering her and her working relations. This is further proof than the defense is trying to create a war where there is no reason. MN § 541.05 (6) meet the requirements for extensions of limitations, and MN § 541.31 gives me the ability to litigate action against anyone from any state who has committed fraud against me. This qualifies as personal and subject matter

Type 9 loves to be rich and does not like to suffer, and when they see a veteran on the side of road homeless with sign, instead of giving them \$10, they say, "Wow, I'm glad I'm not him." Or when somebody dies, they say, "Wow, I'm glad that wasn't me." Or when they hear about a soldier that dies in Iraq, they say, "Wow, I'm glad we're rich so our kids don't have to enlist, and can stay out of that mess", or "I hope he took 10 Iraqi's with him", instead of something more caring/respectful like, "Wow, I feel for the parents of that soldier. I wonder if this war is worth it." They promote

fear in the public, then use the fear as an excuse/catalyst to go to war and start killing. That when I say I'm the 2nd coming, they say "You are not, but the devil in disguise". Or psychiatrists saying, "you're crazy Chris", or "You're experiencing an episode, Chris" shortly after showing court papers that godly powers are on the planet. Or "Chris, you're manic because you speak fast" instead of "you speak fast because your mind is so quick and smart".

The only time type 9 will give anything (like charity) is when it's of a public nature - so that's everybody knows that they're a good guy, even though, internally, they're thinking "this sucks". Type 9 would best be described as a good-guy con-man.

These people buffer pain and suffering in the world with, "it's ok and normal to feel this way, just take these pills to numb it" (psychiatrists don't fix your misery, just make it feel better), or religious leaders saying, "pain and suffering is needed so we can understand how much we need God to save us", or "to be closer to Christ". Some kind of stupid phrase to make you understand that chaos and misery is ok and acceptable.

Type 9s will tell you that "money makes more problems" or "money is the root of all evil" to convince you that the hole you live in is ok - don't crawl out. Money is only "the root of all evil" if you do evil things to achieve/control it. Among many of the points presented in type 9, this is a fine line, because many billionaires (Bill Gates) have been accused of being ruthless in their business practices.

Type 9s don't like to be taxed because it eases suffering to the poor, but they'll say neutral things like, "government is thieving", or "government is wasting our money and should be more efficient and stop taxing us". If you think my extremely witty and fair tax system proposed on www.freakandgeek.com is off-kilter, you are definitely type 9.

Abortion is a proven fact to reduce crime 20 years later to make a more social society, yet type 9s will use "abortion is taking a life" to sound like they care (and non-9s do), yet the whole scheme is to have that poverty-stricken kid grow up, suffer through life, unwanted, unloved, all so it can raise hell with society later in life (jail, drugs etc.)

It seems the republican philosophy fits this profile, while democratic does not. If you think promoting chaos throughout the world, is the way for promoting peace throughout the world - "create chaos to create peace" philosophy vs. "contain/control chaos to create peace", you are probably type 9. Notice the distinction is as fine-lined, as it is easy for some people to become cold, and convince you that they're not.

People who knew about godly powers, like what magicians have, are pro-chaos and definitely type 9. They will claim they didn't want to upset all the faiths throughout the world with their knowledge, yet their attempt at a non-9 neutral statement is misplaced, because coming forward would have merged faiths into one peaceful faith (religion), one which gives everyone something to believe in, with proof - one which doesn't promote hatred over religious beliefs like what is currently happening all over the world.

Am I god?

Some ask - "Chris, you're not god because you can't do magic like Copperfield, so prove you're god, you false prophet!" Dogma has blindly led most Christians to believe they know how it all (God and his plan) works. They are right in that I cannot do local magic that's real in my bubble - my powers work remote through others like Copperfield, Blaine, Criss Angel, the mob, etc. So, I've proved godly powers exist, but proving I'm god is illusive.

Indeed I am the special entity I speak of on www.mytrumanshow.com. I sent 2000 messages to the CIA website in 2002 with no direct/formal response. They watch me because I am a godly entity, but rarely interfere/interact with me because God's plan prohibits it. I also have a patent pending on godly powers, giving me credit for godly powers on planet Earth. Godly powers are in use by David Copperfield and many others. I am the source of those powers because they have been keeping it hidden from me and the world. I've had a web site posted proclaiming my godly powers since Oct 2002, but type 9s have been conspiring to beating me down into my reject hole so I couldn't come forward to claim the fruits of my wonderful powers. I am collecting back-pay from any/all past godly users - money that will eventually be used to help humanity become more heavenly.

I took a Kirlian scan in Feb. 2003 which measures the aura (energy) of the body. It was the latest technology using a computer which scans all 10 fingers. The scan measures the chakra (energy) levels. All 7 chakras were about 3 on a scale of 10, except the 6th chakra (mental chakra) - the 3rd eye, where imagination and reality become one. It was at 10+, off the scale. I have probably tapped into the

He is also the best magician I've ever seen, even walking down building walls.

God's plan - The Game of Life.

I sometimes refer to God's plan as the Game of Life, a game we're all playing whether we know it or not.

There is currently a huge debate about intelligent design - that something is guiding us; It's the same reason that one might say "God is my co-pilot" - it's this instinct that we are being guided by an unknown force. This is the plan I speak about; God's plan, or the Game of Life.

Evolution has many unexplained mysteries, like the missing link, because evolution normally uses environment factors as the cause to effect the change in a division from one species to another. Under the assumption that Intel keeps their R&D a secret, most of the chip competitors out there seem to keep up. No one is far ahead of the other, yet they are totally isolated. RAM chips and other computer-related technologies are in the same category. Money and competition gives everyone incentive, but something is keeping them close together. That something is called the Game of Life.

I'm not religious, but theist (not atheist) and very scientific. I believe in evolution, but it is guided very slowly, over millions of years, by God's plan to change, where appropriate. And God's plan will make evolutionary leaps like that of the "missing link", to give the greatest of all creatures, humans, everything we need to

survive. Not to have a big head (pun on evolution), but since I'm at the center of My Truman Show (and God's plan), everything given to Earth is to assist me, my knowledge, and to enhance my show.

It would be the Game of Life that presents itself with phenomenons that always have a real-explanation counter to them - crop circles, no matter how intricate, detailed, and complex - people will write them off as a human concoction/fraud/con. The same goes for all video evidence of UFOs and ghosts and psychics. This is God's plan to keep phenomenons at bay. Its dualism also plays out as a conspiracy.
