This would be one of the most inhumane events of my life, and why I question the existence of the mental health profession. On August 24, 2000, I was admitted to Sioux Valley Hospital Behavioral Health Services after complaining I had been possibly poisoned by some co-workers at GE Medical Systems in Sioux Falls, SD. A couple days before this, I had thrown up horribly after eating some pizza. I went into the hospital emergency room with the advice of coworker Noah Allard. I also brought in a coffee sample I suspect was laced days prior to this event. The hospital found out I was bi-polar, and decreed I was insane and wrong with my accusations.

This is where it would hit home about what mental illness can mean. I told this place a dozen times to check my blood for poison, and since it's possible I was

poisoned, they threatened my life by not checking and treating me for the poison. There was a poison control sticker, plain as day on the ER wall that they can use for checking my blood. I guess that sticker was meant for sane people, not the mentally ill. I was no longer human, but an animal. What made it worse is that the people poisoning me now found out that I was investigating them, all when I was trying to keep the blood test a secret. The doctors locked me up at a mental institution (cage), which publicized the event, because they thought I was dangerous to myself/society, when in fact, I was the one in danger from others. They put the moron in oxymoron! These people broke laws to protect human life, despite being told a dozen times to do the right thing, all in the name of mental illness.

There was a motive for the poisoning but they did not want to hear it. They did not want to investigate anything I said and insisted I was wrong. They completely interrupted my private investigation, did not test my blood for poison, threw away a coffee sample I brought in, suspected as laced, injected me with a shot of Serentil to sedate me, then caged me up for three days, announcing to my employer the whole incident.

The hospital records said, "use Serentil and Droperidol as needed for extreme agitation." This is what they initially injected me with, but my agitation was them - for the fact that they were not testing my blood, and not believing anything I said, and for tossing me into a cage for simply trying to conduct a private investigation.

"Hi risk of self-harm because of poor reality testing because of grandiosity and active paranoia". These people make assumptions based on past diagnosis of

mentally ill, then continue the legacy of professional name calling, calling me bipolar, psychotic, mentally ill, delusional, etc. In other words, "loser/reject".

psychosis:

- A severe mental disorder, with or without organic damage, characterized by derangement of personality and loss of contact with reality and causing deterioration of normal social functioning.
- Any severe mental disorder in which contact with reality is lost or highly distorted.

Medical professionals carry a huge degree of stature and credibility - when they say something, it's usually true. When a doctor says you have cancer, chances are very likely you do indeed have cancer. When the doctor says that I'm mentally ill and psychotic, many people are going to believe it, and that damages my credibility, my stature, and a future ability to perform an important job, including the Presidency of the United States.

It is very easy to become mentally ill. For instance, if the judge wants to conduct a test, he could go to a psychiatrist, and tell him that he thinks he's Jesus. Within minutes, that honorable and respected judge would be declared mentally ill with bipolar within minutes of that conversation. That's how easy it is to become mentally ill. They conduct absolutely no blood-work or brain scans. Then watch over the next few years as your life starts to crumble. Now the judge doesn't need to conduct this experiment because there is mounds of evidence to support this claim, and the devastating aftermath of such a diagnosis.

I am called mentally ill, psychotic, bipolar, and delusional. Mental illness has some serious side effects with public perception. In talking with an expert nurse, she and her mother are both psychiatric nurses. She says that most people who get

diagnosed with mental illness often result in deterioration of social status - many to the point in which they're living in the streets, homeless. She said that this occurs largely from the fact that they can't get a job because they've been diagnosed with mental illness. It's not the mental illness that they allegedly have that caused their homelessness - it's being called mentally ill that lost the job and put them on the street.

My situation is not much different. I would be homeless if I didn't have Social Security disability and good parents. If I would never have been diagnosed with mental illness, I probably would not have lost my last job, been placed on Social Security Disability, and been divorced. My hardships in the last six years can be largely attributed to the fact that I have been diagnosed with mental illness, and like a plague of continuance, it keeps haunting me, in the form of more caging (institutionalized recently on 28Oct2004 because I say I'm god on my website www.mytrumanshow.com). Nobody gives me any credibility for anything I say, and many people are scared of people with mental illness because an insanity defense essentially gives a mentally ill person a license to kill.

The defendants might say that my mental illness caused my job and marital problems, but the psychiatrists never did a neuro-brain scan to actually determine that there IS something wrong with my brain. For years, they are calling me psychotic and schizophrenic without ever doing a neuro-brain scan like those talked about on www.schizophrenia.com. These doctors call you mentally ill without any tests to prove it. If you say something weird, you are stamped mentally ill for life (like a "reject" stamp).

Sioux Valley's actions showed just how inhumane people treat me because I'm

mentally ill. They gave me absolutely no credibility. Now imagine the damages if my web site is actually true - that I am god. I currently have a lawsuit pending against David Copperfield for using my magical powers without my permission. The case number is Cv. 05-446 JRT/FLN. When the suit matures, from the psychiatrists viewpoint, that would mean that I'm a psychotic god, who doesn't know reality and could possibly harm people with my magic - that's the devil. That's very damaging, and the results of the suit will determine the extent of the damages suffered as a result of Sioux Valley's diagnosis. That would mean that all the psychiatrists are wrong about my site. That would then lead to a wrong diagnosis about me being mentally ill, delusional, including the one about being psychotic, normally associated with an unstable psychotic killer. All the years of being caged and drugged up were perhaps erroneous. Wow! It's going to take a lot of commercial time and money to counteract this stigma given to me by professional doctors who proclaim their status as credible.

Bill Gates has already contacted me about running for president in 2008. This lawsuit hinges upon the David Copperfield case, and the damages are yet to be determined. It may take years to determine the amount of damage suffered while trying to run for President of the United States, under the notion of mentally ill and psychotic by professional doctors who proclaim their status as credible. I am suing Sioux Valley Hospital for medical malpractice, slander, and libel, for calling me mentally ill and psychotic without proving it first (neuro-scans). For calling me wrong all these years under the premise of mentally ill. For damaging my past and future credibility, my stature, and the public's persona of me to perform an important job, including the Presidency of the United States.

- Incorrect diagnosis - medical malpractice - endangering my life.

- Slander and libel - failure to give me any credit to what I say.
- For treating me like an animal instead of a human being.
- Slander for the stigma of a mentally ill person capable of running for President of the United States.
- Obstruction of a criminal investigation in an attempted murder of a future president of the United States.
- Lost wages from the lost job as a result of 20mg Zyprexa making me groggy in the morning, hindering my creativity which hindered my productivity and personality on the job.
- Publicizing my caging to my employer, eventually resulting in job loss.
- Pain and suffering - very suicidal (ultimately with plan) following job loss.

I recently found out that Sioux Valley, during the incident, was trying to commit me (institutionalize me for months at Yankton) so that I would take my medication - eventually talked down by my wife, Maria. In Exhibit "Allina Conspiracy", I talk about a psychiatric conspiracy against Chris Roller, a godly entity. For the same exact reasons, I believe there is a conspiracy, by Sioux Valley, against me, Chris Roller, the second coming, a godly entity, to call me mentally ill, psychotic, bipolar, etc, to keep me from coming forward to claim the fruits of my godly powers. This very harmful name-calling hurts my feelings (essentially calling me a loser) and causes people to be afraid of me (because I'm mentally ill). It also discriminates against my First Amendments religious freedoms I express at www.mytrumanshow.com (shown in Quello/Fairview complaint - 19-C7-05-6586). This also violates some statutes, namely, Conspiracies to Interfere With Civil Rights (42 U.S.C. § 1985), and Conspiracy Against Rights of Citizens (18 U.S.C. § 241). I am suing Sioux Valley Hospital for \$5 trillion for conspiracy against a godly entity.
