Affidavit of Chris Roller

Given...

CR=Christopher Roller

I, Christopher Roller, solemnly swear under oath,

I have noticed the law enforcement seems to be wary of me near courthouse, cautious that I may hurt somebody as a result of this case or the continued harassment by the legal system in the past 5 years. So I want you be assured that you are safe from me (each List #1). In return, I expect similar statements from you (each in List #1), assuring my safety from you.

For the following...

1. CR does not physically molest XXX's children
2. CR has not threatened via voice(to-person), nor conspired, any personal physical harm (including to kill) intended on XXX.

XXX will be substituted and re-iterated with the following people in List #1.

List #1:

1. Judge George Harrelson
2. Judge Michelle Dietrich
3. Sheriff Randy Hansen
4. Chief of Police Mark Dressen
5. Brenda Dressen

6. Psychologist Linda Marshall
7. County Attorney Steven Collins
8. Judge Leland Bush
9. Psychiatrist Charles Dean

For the sake of redundancy and typing error, this means there are 18 sworn statements made, 2 for each person in List #1.

I expect a statement from each person in List #1 to submit a statement to me assuring me my safety from them.

I, CR, do and will threaten with intention the following to people in voice (to person)

1. CR accuses people of molesting CR's children because in asking during previous lawsuits, nobody is denying it, meaning it's true.
2. CR accuses people of conspiring to kill CR because in asking during previous lawsuits, nobody is denying it, meaning it is true.
3. CR has a habit of suing people when he feels they are hiding criminal behavior, and/or unable to swear against any allegations when asked, prior to court battle.
4. CR does post volatile allegations made in the courtroom to the internet in hopes of "shaping people up" (better behavior).

CR knows he is psychic and can prove it very easily. Using this psychic sense, CR can detect when people are lying to him (a feature of www.TruthUnderOath.com). Using this ability, CR has strongly determined that people are able to lie while under oath in certain cases. CR has noticed, in the last 14 months, that people are able to lie verbally while under oath (even in the courtroom), and lie on written statements under oath, as long as it's not submitted into a court docket.

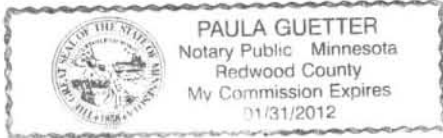
